Fire Fighting Measures

For massive fire, use unmanned hose holders or monitor nozzles; if this is impossible withdraw from area and let fire burn. For tank, rail car or tank truck, evacuation radius: 1600 meters (1 mile). Avoid inhalation of material or combustion by-products. Stay upwind and keep out of low areas.

Special Protective Equipment and Precautions for Firefighters
